No. ER-236.6.44/ERCAPP2788/B.Ed./2017/52251, dated 12.04.2017, the Hon'ble Vice-Chancellor is pleased to grant affiliation of B.Ed. Programme of your Institution under The West Bengal University of Teachers' Training, Education Planning and Administration for the academic year 2017-2018 subject to the fulfillment of the following terms and conditions:

1. The college shall be guided by the NCTE Regulations 2014 in respect of appointment of teaching and non-teaching staff, purchase of books, audio-visual material and automation of the library.
2. The college will continue to organize and equip the laboratories as per stipulation of NCTE. Other infrastructure are to be maintained as per NCTE norms.
3. The said college shall be obliged to follow the fee structure and other terms and conditions specified by the State Government /Competent Authority under NCTE regulations from time to time. Appropriate action shall be taken if any irregularities are found in this regard.
4. Intake capacity will be as per NCTE norms.
5. Appointment of faculty already done/ to be done in future and their pay and allowances must follow the latest NCTE, UGC and State govt. norms.
